MINUTES

ACTION

1 DECLARATIONS OF INTEREST

There were no new declarations of interest at this meeting.

2 COVID-19 MEASURES

The Board discussed the enormity of the issues arising as a result of the COVID-19 outbreak, the impact on the Buckinghamshire business community, the measures being put in place to mitigate impact, and the support that individual organisations can provide.

Government has announced impressive fiscal measures, but it is quite clear small and micro businesses in Buckinghamshire are suffering and concern was expressed at the length of time it will take Government resources to reach businesses in need.

It was suggested there is also a wider conversation to be had with Government around how to utilise unallocated national funding eg ESIF funds. This is something also being pressed for through the LEP Network (letter previously circulated), in addition to LEPs having the flexibility

to utilise existing growth funding to provide liquidity for businesses. LEPs and Growth Hubs have the ability to be points of rapid response to the current situation and are looking for help from Government to support this work. The overriding message is one of the need for speed to get resources to where they are most needed.

The Board noted the establishment of the Resilience Forum (Buckinghamshire County Council, BLEP and BBF) putting combined effort to ensuring Buckinghamshire's economic survival.

The Board heard releasing unutilised local growth/other funds could establish a 'pot' of around £1.8m to provide immediate assistance to businesses, subject to Government approval re using capital funds for revenue purposes, Section 151 officer approval, and appropriate due diligence on the businesses applying (for which there is an existing pipeline through contact with BBF). The criteria for allocating this funding will need to be agreed with BLEP's Capital Programme Sub Committee, but it was envisioned the focus would be on robust businesses currently ineligible for national support.

It was confirmed the ask to the BLEP Board, therefore, was for approval to utilise headroom in the current Growth Fund (once approved by Government), releasing these monies for the relief of businesses in Buckinghamshire.

It was noted BBF will take no management fee for the distribution of this fund, all monies going directly to the business community. BBF having a good knowledge of and being in regular contact with its 12k business members estimated the application process/assessment could be handled very quickly with approved funds being transferred same day. The impact of this funding on protecting jobs/businesses will be recorded and shared with Government.

It was confirmed the funds provided will likely be a mixture of grant funding to cashflow smaller businesses or may form a loan for those businesses able to benefit from other Government initiatives, in which case it was anticipated loan funds would be returned to the 'pot'.

The Board questioned whether Local Authority partners were in a position to provide match funding. **MT undertook to look into this**.

It was confirmed the Local Growth Fund monies to be released had been earmarked to support the Marlow to Maidenhead Railway but this project has seen significant delays in progression. It was hoped to support the project from a future tranche of Local Growth Fund monies.

In discussion, Board members expressed significant concern at punitive levels of interest and personal guarantees being asked of businesses by some banks; anecdotal evidence being supported through a recent BBF survey. It was suggested this must be fed back to Government and addressed going forward.

Board members requested more information on Government's 'Hardship Fund' which it was believed is intended for the support of businesses. **KH to forward information.**

The Board agreed:

- > Subject to Government approval, the release of £1.8m Local Growth Fund monies for the immediate relief of Buckinghamshire businesses struggling as a result of COVID-19 virus.
- > To press Government for accelerated release of recently announced tranches of Local Growth Funding to be used within this 'Resilience Pot', together with any other sources of funding announced.

> Subject to Government approval, to expedite release of Growth Hub capacity funding in a single payment at the beginning of the financial year (rather than in staged payments throughout the year) shoring up cashflow to enable funding to be passported quickly to businesses, and bringing in extra resource, leveraged with Local Authorities, to bring together a team to support this work.
