Acting as a strategic gateway to funding, we support and deliver projects of long-term economic benefit for all in Buckinghamshire.

Our work is primarily concerned with enabling sustainable and productive economic growth through creating more jobs, up-skilling our workforce and by providing the vital supporting infrastructure and housing. I am delighted that we are able to report significant successes within these fields.

Our economy faces an exciting future, and BTVLEP and our partners are working hard to make sure we maximise the potential for business growth across the county.

# **BUILDING ON A STRONG** AND SUCCESSFUL

Buckinghamshire's economy is thriving. Our businesses have the 3rd highest productivity rates in the country behind London and Berkshire. The GVA (Gross Value Added to the National Exchequer) per hour worked is almost 20% above the national average, significantly better than our neighbouring areas in Bedfordshire, Milton Keynes, Oxfordshire and Hertfordshire - or to put it another way, an employee in Buckinghamshire can produce in 4 days what it would take somebody in many parts of the country to produce in a standard working week.

**ECONOMY** 

But we are not complacent and we continue to support our high potential businesses and key growth sectors to flourish and grow further and access new national and international markets.

With one-third of the county designated an Area of Outstanding Natural Beauty and our grammar schools leading the way in the best performing schools system in the country, Buckinghamshire is a draw for talent, with evidence showing we have the best educated workforce in the land.

In addition, Buckinghamshire is at the centre of England's Economic Heartland, an area that stretches from Oxfordshire to Cambridgeshire. The heartland has an economy valued at £92.5bn, and is home to 175,000 businesses employing 1,640,000 people.

Buckinghamshire therefore offers the perfect location for international focused businesses, including Bosch, Pinewood, ESRI, Silverson, Cisco, McAfee and many more.



#### **SECURING INVESTMENT**





When compared with the City Deal areas, we make an impressive larger contribution to national output through our exceptional productivity levels.


# OUT-PERFORMING CITIES...

### LOCAL GROWTH FUND — INCREASING PROSPERITY AND GROWTH

This funding is enabling the delivery of new road and rail infrastructure, better skills and business opportunities and enhancing digital connectivity to support sustainable economic growth in Bucks.

In the past 12 months our Local Growth Fund investment has helped support new educational facilities at the world leading National Film and Television School, new facilities for the creative industries and construction and motor trades have been created at the Buckinghamshire College Group sites and work is almost complete on the new Vinson Centre for Entrepreneurship at the University of Buckingham. This performance in our Local Growth Fund Delivery has enabled BTVLEP to be graded good on all fronts in the Government's annual assessment of Local Enterprise Partnerships.

# NEW UNIVERSITY CENTRE FOR INNOVATION AND ENTREPRENEURSHIP



The University of Buckingham's ambition to be one of the world's best independent universities, moved closer with work starting on the BTVLEP funded Vinson Centre for Liberal Economics, Innovation and Entrepreneurship. The centre will build on the University's internationally recognised reputation in the teaching of entrepreneurship and is part of an ambitious £150m programme of growth. The results are already there to see, with student recruitment bucking national trends and increasing 25% this year as the University goes from strength to strength under the inspirational leadership of Sir Anthony Seldon.

# LIGHTS, CAMERA, ACTION ...AND ECONOMIC GROWTH



Business Minister Lord Henley earlier this year took the opportunity to come to Bucks to see first-hand the thriving creative hub at Pinewood Studios and to learn about the impact of recent investment - not least the National Film and Television School's 4k Digital Content Training Studio; the A355 scheme to improve north/south transport connectivity to promote economic growth; and investment in the University of Buckingham Centre for Entrepreneurship.





# FIRING UP MAJOR INVESTMENT — GROWING PLACES FUND

BTVLEP is investing, recycling and re-investing its  $\pounds 8.1$ m Growing Places Fund on projects that offer great returns for Bucks on jobs, business critical infrastructure and growth.

We have already demonstrated our ability to deliver an ambitious programme. 100% of our Growing Places Funding has been used to kick-start the regeneration of the town centres and access gateways in Aylesbury and High Wycombe, in addition to supporting tourism, BTVLEP's skills and wider growth programmes.

## ROYAL APPROVAL FOR BTVLEP FUNDED SILVERSTONE HERITAGE EXPERIENCE



The Duke of Sussex has given the green light to The Silverstone Heritage Experience centre, which will provide an exhilarating journey through motor racing past, present and future. Supported by a £1m BTVLEP Growing Places Fund loan investment, the centre, which is due to open in Spring 2019, will attract up to half a million visitors a year and further drive the business and sporting benefits generated by one of Britain's greatest assets. This booming sector provides employment in Bucks for an estimated 36,000 people having grown twice as fast as the local economy since 2009.

# EUROPEAN FUNDING CONTINUES TO SECURE JOBS AND GROWTH IN BUCKS

The 2014 to 2020 European Structural and Investment Funds (ESIF) bring the European Regional Development Fund (ERDF), European Social Fund (ESF) and part of the European Agricultural Fund for Rural Development (EAFRD) together into a single Growth Programme for England. This supports our key growth priorities of innovation, research and development, support for small and medium sized enterprises, low carbon, skills and employment.

The Government has confirmed that it will guarantee EU funding for structural and investment fund projects signed before the UK's departure from the EU.

Businesses and communities across Buckinghamshire have benefited from  $\pounds 10.9 \text{m}$  of European funding, secured by BTVLEP, for growth and jobs. This significant milestone, which presents a significant opportunity for local business and organisations, is making a real difference to our local economy. Projects supported by this funding include:

#### **Skills Brokerage Service**

Identifying training opportunities to increase the productivity of over 1,000 Buckinghamshire based businesses.

#### **Low Carbon Workspaces**

Awards grants between £1,000 and £5,000 to help small to medium sized business enterprises (SME) in Buckinghamshire install energy saving projects.

#### **Rural Funding**

Awards to support the development and diversification in our rural and tourism businesses.

#### **Halo Growth Programme**

Businesses can access either tailored business growth advice or £1,000 Growth Grants.

#### **Business Incubation Space**

Our European programme funding has enabled business incubation and support services to be established in High Wycombe, Stoke Mandeville and at Westcott, providing invaluable support for start-ups and growing businesses in the health, social care and space and rocket propulsion sectors.

#### **OUR BUSINESS PLANS**

Buckinghamshire's overall economic position relative to other LEP areas remains strong with high rates of economic participation, low unemployment, a well skilled workforce and a strong enterprise base. But there are major challenges!

Our key challenge is to change Government's perception of Buckinghamshire as a prosperous, leafy, well-educated community in need of little support, taking for granted our continuing significant contributions to the UK economy. The fact is that we are a largely rural county whose digital, road and rail infrastructure needs critical new investment.

Our Strategic Economic Plan highlights local aims to deliver increased prosperity and jobs for Buckinghamshire by putting any available funds to work, by focusing on better transport connectivity, helping businesses to grow faster, and bringing business and education together more fruitfully.

#### WHAT WE AIM TO DO

The focus for the LEP is in preparing the ground for continued prosperity through enabling sustainable economic growth:

- To get the right economic growth decisions taken more quickly:
- To stimulate more smart and sustainable business growth in the county;
- To bring forward the necessary business-critical infrastructure;
- To secure the inward investment needed to underpin growth;
- To ensure the supply of the skilled, flexible workforce needed by our firms.

## NOT JUST FAST BUT SUPERFAST BUCKS

Buckinghamshire's great performance in the first phase of the roll-out of broadband across the county – with take-up of superfast services at 48%, the third highest in the UK - has resulted in further funding of over £800,000 from BTVLEP and partners to extend the next phase to provide broadband coverage to a further 2,500 homes and businesses, in addition to the 12,500 already scheduled for the next phase of rollout. As one of the most productive economies in the country we want to continue to provide the conditions for businesses to thrive at the beating heart of the national economy, which is why we continue to push for 100% superfast broadband coverage.

#### STRATEGIC ECONOMIC PLAN

Our Strategic Economic Plan (SEP) for Buckinghamshire reflects the government's policy for local economic growth, the emerging UK Industrial Strategy framework, the work of England's Economic Heartland Strategic Alliance and the changed local planning conditions.

Our SEP sets out ambitions to 2031 to drive innovation and accelerated economic growth to meet the needs of our economy and place Buckinghamshire at the forefront of the UK's global growth ambitions.

# TOP GEAR FOR AUTOMOTIVE STUDENTS



BTVLEP allocation of £2.69m Local Growth Funding, has provided an impressive new technical and construction trades facility at Buckinghamshire College Group's Wycombe Campus, which will open up new opportunities for students in the automotive sector. Opened by our Chief Executive Richard Harrington, the new facility offers students the chance to learn on campus in modern surroundings and the opportunity to develop their automotive skills. Investment into Buckinghamshire College Group reinforces BTVLEP's Strategic Economic Plan to support and develop key business sectors and adds a further catalyst for economic development.

#### AN ENABLER FOR GROWTH

Buckinghamshire Thames Valley LEP is an enabling body which seeks to create a business-friendly environment in which organisations can succeed. We have worked with our partners to identify an approach for directing and prioritising our activity and achieving improved business productivity. As a result of this approach, we have achieved great success during 2017/18.

#### TALKING LOUD AND CLEAR

We use BTVLEPs powerful national, regional and local voice to ensure that critical infrastructure projects such as East-West Rail and Cross-rail are delivered on schedule. We are currently supporting the case to advance development for business critical national infrastructure projects such as the Oxford-Cambridge Expressway and the expansion of Heathrow airport and access to Old Oak Common.

#### TRANS BUCKS EXPRESS

Transport investment is a necessary condition for the continued delivery of economic and housing growth in Buckinghamshire. BTVLEP therefore welcomes the recent study, produced in partnership with England's Economic Heartland, recommending connecting the Chiltern mainline to Old Oak Common. This connection will not only strengthen the strategic importance of East West Rail but improve surface access to Heathrow and other London transport hubs. In addition, this study supports the aims of our Growth Strategy to show how the county, at the heart of the Oxford to Cambridge Growth Corridor, can complement London and the wider Thames Valley to drive productivity, growth and to reach its true economic potential.

#### A GROWTH HUB GOING PLACES

Our Business Growth Hub, Buckinghamshire Business First, is the envy of almost every Local Enterprise Partnership in England. The organisation has an unprecedented reach with over 11,000 business members representing over 70% of the workforce of Buckinghamshire. Over 60% of those businesses have been supported in the past 12 months, receiving business advice, networking support and growth funding amongst the suite of services offered.

In total Buckinghamshire Business First have supported a total over 30,000 separate business engagements last year and secured almost £3m to support the economy of Buckinghamshire.

#### **DELIVERY PARTNERSHIPS**

Buckinghamshire Advantage has accelerated the development and delivery of a variety of projects and schemes, including the Aylesbury Woodlands mixed use development covering over 200ha of employment led development to the east of Aylesbury, providing much needed new road infrastructure and supporting the growth of the Aylesbury Garden Town programme. Buckinghamshire Advantage has also enabled the Aylesbury Waterside and the Handy Cross development in High Wycombe, and is now rocket fuelling investment into our Enterprise Zone sites.

#### **ROCKET FUELLED ENTERPRISE ZONE**

In 2016 Buckinghamshire Thames Valley Local Enterprise Partnership secured Enterprise Zone status for three key strategic employment sites in Buckinghamshire. Two years on the sites at Silverstone Park, Westcott Venture Park and at Aylesbury Woodlands are driving forward the Buckinghamshire economy in the sectors of high-performance engineering, space technology and life sciences – all critical to the national economy and just as importantly securing business rate returns to be reinvested into the local business community.



At **Silverstone** the first phase of the Enterprise Zone, consisting 125,000 sq. ft. of new employment space, built by MEPC, is now almost full attracting businesses of the calibre of Virgin Racing, the World Champion Mercedes-AMG Petronas Formula 1 Team, David Brown Automotive and Twintec Baumot. £5m of retained business rates has been invested into a new multi-utility trench to advance the development of future phases of development, and a further £2m of Local Growth Funding has been committed to develop a new Innovation Centre providing businesses access to the UK's premier aerodynamics facility for racing cycles and sports equipment.

### **ALL ENGINES FIRING**



Space may be Captain Kirk's final frontier but it is also Bucks. BTVLEP has long recognised, and invested in, the potential of Westcott Venture Park as a global player in space propulsion technologies. Building on this reputation,



At **Westcott** a mixture of UK Government, UK Space Agency and European Funding has been secured to create a new vibrant centre for space propulsion testing and development. New facilities include a 5G test centre for unmanned automated vehicles, being managed by the Satellite Application Catapult, alongside incubation facilities for businesses operating in the sector. Reaction Engines' landmark testing facility for the ground-breaking SABRE engine is well underway and work will shortly start on the UK Space Agency's Innovation Centre for rocket propulsion - all this activity puts Westcott at the heart of the UK's Space Sector!



**Aylesbury Woodlands** will form one the largest new employment sites in the south of England. The Woodlands development was important to Aylesbury securing Garden Town Status and will help deliver the Eastern Link road, a vital element in the transport infrastructure needed for the growth in Aylesbury and beyond. The Woodlands site will also provide the opportunity to develop over 1100 homes, including 160 custom built housing units, providing a template for a viable alternative to the major housing developers. Most recently at Woodlands construction has commenced on over 250,000 sq ft of new employment floorspace.

The scale and specialised nature of the development, the mix of uses and the highly strategic position at the heart of the 'Oxford to Cambridge Growth Corridor', enables the Aylesbury Vale Enterprise Zone to challenge internationally as a major new employment location over the coming years.

# ENSURING BUSINESSES HAVE THE RIGHT SKILLED WORKFORCE

The Bucks Skills Hub, by working with local schools and colleges, is connecting young people with business to develop a dynamic programme of employer engagement. An effective ecosystem of skills development and careers inspiration is evolving. While the careers inspiration work is broad, there is a focus on our identified growth sectors ensuring that young people's ambitions are aligned to where they will be needed most

During the past 12 months our Skills Hub, working closely with Buckinghamshire County Council, has established a new skills strategy for the area. Seeking to ensure that training providers deliver the skills needed for business, the strategy also seeks to extend the opportunities for vocational learning to help retain young talent in the county. Our skills programme also firmly established the Bucks Skills Show as an invaluable event to inform young people of career opportunities; became only the second area in the country to have comprehensive Enterprise Adviser coverage in all secondary schools; developed an extensive apprenticeship support programme; and produced a detailed Labour Market insight assessment to assess the latest trends in the employment market across business sectors.

Underpinning the skills programme is robust research which proves that exposing young people to at least four encounters with employers during their school career reduces their chances of leaving education or training without a job and increases their earning potential. By early 2018, the Bucks Skills Hub had supported or helped facilitate 52,000 student-employer encounters — our ultimate target is for every student to have at least one employer encounter per term.

## BUCKINGHAMSHIRE SECTOR ACTION GROUPS

Our key employer-led sector action groups in Buckinghamshire are tasked with devising activities and initiatives to address sector-specific skills issues and economic development challenges for our growth sectors. The aim is to explore skills issues, recruitment needs, local impact, future trends and technological advances for each sector (particularly linked to three Enterprise Zones) both for existing Bucks businesses and support the proposition for businesses considering locating here.
